## **IMPORTANT - Brown Marmorated Stink Bug Season 2019-20**

**Dear Valued Customer,**

Australia Department of Agriculture and Water Resources (DAWR) will start the seasonal import measures to manage the risk of Brown marmorated stink bug (BMSB) during the high-risk season soon.

New seasonal measures will apply for goods shipped on or between 1 September 2019 and 31 May 2020.

This will apply to all sea freight cargo from the below target risk countries with cargo are being considered as high-risk goods, basically do not load any sea freight cargo (LCL, FCL, Breakbulk) unless shipper can provide an accepted treatment certificated from an approved treatment provider.

### **Target risk countries**

- USA
- Italy
- Germany
- France
- Russia
- Greece
- Hungary
- Romania
- Georgia
- Japan (heightened vessel surveillance only)
